OUR BOARD MEMBERS INCLUDE PERSONS HAVING SPECIAL KNOWLEDGE AND EXPERTISE IN THE HEALTH LEADERSHIP AND MATERNAL AND CHILD HEALTH CARE AREA. THE BOARD MEMBERS INCLUDE MEMBERS FROM ACCESS COMMUNITY HEALTH NETWORK AND A PROFESSOR OF HEALTH SCIENCES AT DEPAUL UNIVERSITY WHICH HELP TO ENSURE THAT THE ORGANIZATION'S WORK IS RESPONSIVE TO THE COMMUNITY AT LARGE.

WHILE MUCH OF OUR FUNDING COMES FROM A FEW KEY DONORS, WE HAVE A PROGRAM TO SOLICIT THE GENERAL PUBLIC ROUTINELY. WE HOLD FUNDRAISING EVENTS ATTENDED BY THE GENERAL PUBLIC, HAVE DONATION CAPABILITIES ON OUR WEBSITE AND PRODUCE AN ANNUAL REPORT MEANT TO SHOW THE PUBLIC OUR ACCOMPLISHMENTS SO THAT THEY WILL CONTRIBUTE AND ENABLE US TO CONTINUE TO IMPACT THE HEALTH OF WOMEN AND CHILDREN NATIONALLY. IT SHOULD ALSO BE NOTED THAT THE TWO LARGE GRANTS PLEDGED IN THE CURRENT FISCAL YEAR ARE PRIMARILY RELATED TO GRANT PERIODS FALLING IN SUBSEQUENT YEARS, BUT ARE RECORDED CURRENTLY UNDER GENERALLY ACCEPTED ACCOUNTING PRINCIPLES. 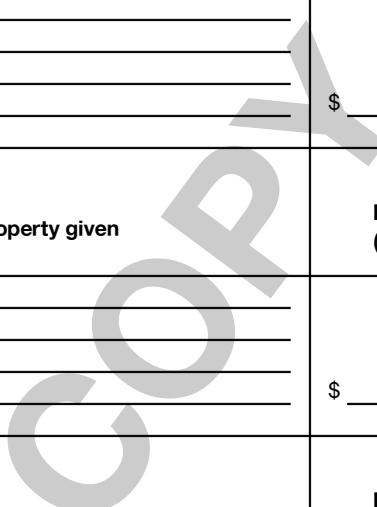

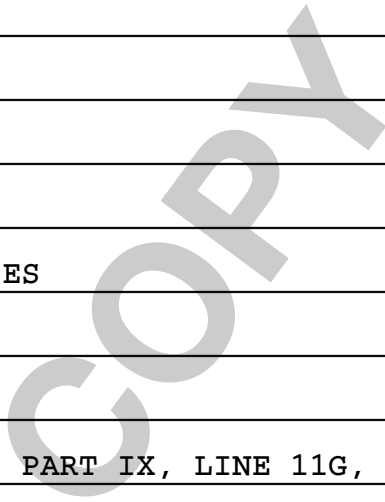
